(Small Cap Fund- An Open Ended Equity Scheme predominantly investing in Small Cap Stocks)

Investment Objective

To achieve long term capital appreciation by investing in a portfolio consisting of equity and equity related securities, predominantly of small cap companies. However, there is no assurance that the investment objective of the scheme will be achieved.

Stock Selection Criteria

The stock selection consists of two step process

- BMV* Filter
- Stock Segmentation

*BMV= Business, Management and Valuation

Characteristics of Small Cap Companies

- Small Cap Companies are defined as companies which have a market capitalisation of less than that of the top 250th listed company in terms of full market capitalisation
- Small Cap Companies Investment Drivers
 - High growth visibility
 - Smaller company gaining market share in a developed industry
 - Early entrant in a highly evolving industry
 - Niche product and service provider in a developed industry

- Fast growing intrinsic value
- Current price closer or higher than intrinsic value

- Business= Strong, Management= Strong, Valuation= Fair



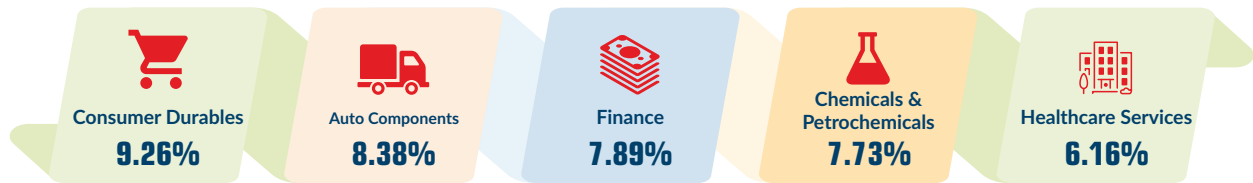
Bargain Stocks

- Sales growth < Nominal GDP[#] growth
- Slow growing intrinsic value
- Current price lower than intrinsic value
- Stock returns mostly coming from multiple re-rating
- Business= Fair, Management= Strong, Valuation= Undervalued

Gross Domestic Product

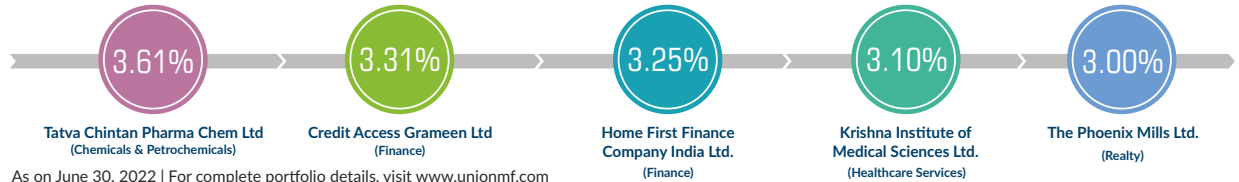
Top 5 Industry Classification
